Target groups for certification

IRIS can be used in the entire global rail sector for companies who focus on production, development, project management, maintenance and repair of railway vehicles and their components, including signalling. The standard was drafted under the auspices of UNIFE (Union des Industries Ferroviaires Européennes) and is supported by the four largest system manufacturers (Bombardier, Siemens, Alstom und Ansaldo-Breda). It is now part of procurement specifications in many organisations. All certified organisations are listed in the IRIS database, which can be accessed by all those involved in the market.

Benefits of certification

Certification according to IRIS offers numerous benefits for enhancing market position and internal quality management:

- IRIS certification is widely recognised as a prerequisite for supplier approval in the railway industry.
- Quality standards within the organisation and the entire supply chain are improved.
- The IRIS database increases the transparency of supplier information.
- The number of system audits by customers can be reduced.

Prerequisites for certification

The certification procedure according to IRIS is based on the requirements of the ISO 9001 standard for quality management systems, with specific requirements for the rail sector added. A scoring procedure is used which provides the audited organisation with a differentiated assessment of its management systems in order to be able to specifically recognise potentials for improvement.
