## Target groups for certification

TÜV NORD CERT offers certification according to three IFS standards:

- IFS Food for food manufacturers – in particular private label manufacturers, but also original brand manufacturers, suppliers etc.

- IFS Logistics for companies offering transport or storage services (including of non-food articles)
- IFS Broker for agencies, traders, brokers and importers (including of non-food articles)

In addition to acting as a ticket for entry to attractive markets, certified organisations benefit from image enhancement, reduced risks and warranty claims, and also know that they are making an active contribution to food safety.
