#### 1. Purpose

The purpose of these terms and conditions are to clearly define the application and limitations of use of the UKCA / CE UKNI markings and TÜV UK's UK Approved Body / Notified Body Northern Ireland Number.

#### 2. Scope

The scope of these terms and conditions cover products by an approved Factory Production Control (FPC) systems assessed by TÜV UK in accordance with the requirements of the applicable standard.

#### 3. Requirements

The UKCA marking and where appropriate the TÜV UK Approved Body Number shall be applied only when the equipment fully complies with the regulations.

The CE UKNI marking and where appropriate the TÜV UK Notified Body Number shall be applied only when the equipment fully complies with the regulations.

Equipment shall only be marked following the approval of the FPC System.

The manufacturer shall supply the names and signatures of the persons authorised to apply the UKCA or CE UKNI marking and or TÜV UK Approved or Notified Body Northern Ireland Number.

The manufacturer shall establish a written procedure for controlling the final UKCA or CE UKNI marking and TÜV UK marking. This procedure shall be approved by TÜV UK Ltd.

The manufacturer shall issue a declaration of conformity, reference the Construction Products Regulation 2011 (retained EU law EUR 305/2011) as amended by the Construction Products (Amendment etc.) (EU Exit) Regulations 2019 and the Construction Products (Amendment etc.) (EU Exit) Regulations 2020.

The Manufacturer shall not issue misleading or otherwise improper advertisements using the UKCA or CE UKNI marking.

The manufacturer shall supply details of all equipment that has been released bearing the TÜV UK Approved Body or Notified Body Northern Ireland Number.

No company or location shall mark equipment with TÜV UK's UK Approved Body or Notified Body Northern Ireland Number other than that shown on the relevant TÜV UK certificate.

The manufacturer shall continuously monitor products marked with the UKCA or CE UKNI marking in accordance with the conformity assessment requirements.

All changes to products must be notified immediately to TÜV UK Ltd as otherwise the products will not conform to the applicable Regulations.

Any defect or damage which becomes apparent subsequent to the examination but which was not detected or recorded during the examination must be notified immediately to TÜV UK Ltd.

Where Surveillance is an essential element for certification, the manufacturer shall allow TÜV UK Ltd to carry out regular checks of production and/or testing facilities at the relevant location(s) identified by the Certificate of the applicable Regulations, at the cost of the holder of the certificate.

Unannounced inspection visits where applicable shall be undertaken at the cost of the applicant at a frequency determined by TÜV UK taking into account the extent of the manufacturer's use of internal inspections, the status of the manufacturer's quality management system and the emergence of quality problems during production.

The holder of a TÜV UK Certificate shall not publish or copy TÜV UK Ltd certificates without the prior approval of TÜV UK Ltd.
