

Introduction

The following information summarises and applies the use of the Accredited Registration Logo (based on *The National Accreditation Logo & Symbols: Conditions for use by UKAS and UKAS accredited organisations* issued June 2018) and TÜV UK Registration Logo by holders of TÜV UK Limited Management System certificates that are covered by our accreditation to ISO17021.

Requirements

1. General Requirements & Restrictions –

All Logos in Paragraphs 2 & 3: -

- a) May only be used in conjunction with the specific management system standards to which they apply as indicated.
- b) Should not have their proportions from the illustrated / supplied versions as per Paragraphs 2 & 3; TÜV UK supply electronic versions to clients with current certification.
- c) May be used on any stationery and literature that relates to the certified activities and can be used on websites, letter headings, invoices and other stationery; in advertising and promotional materials and publications in association with your business name
- d) Should not be used in a misleading way that may cause confusion as to which products, or services are included in the Scope of Certification
- e) May not be displayed on any product or equipment supplied by the company. Where a service is provided you must not display the mark in any way which may suggest that the service is approved by TÜV UK Limited or UKAS. This ruling extends to the labelling or packaging of products and any laboratory test, calibration or inspection reports; such reports are deemed to be products in this context.

- f) Logos that are used on product packaging or in or any statement on it or in accompanying information indicating that the certified client has a certified management system shall in no way imply that the product, process or service is certified by this means.

Product packaging is considered as that which can be removed without the product disintegrating or being damaged.

Accompanying information is considered as separately available or easily detachable.

Type labels or identification plates are considered as part of the product.

Accompanying information / statements shall include reference to:

- identification (e.g. brand or name) of the certified client;

- the type of management system (e.g. quality, environment) and the applicable standard;
 - the certification body issuing the certificate (TÜV UK Ltd in case of UKAS).
- g) Certificate numbers as shown below the illustrated logos need only be identified when the full company name and details are not clearly shown.

In addition to the general requirements and restrictions in Paragraph 1, the logos illustrated in paragraph 2 shown above: -

- a) May only be used when all parts of a company's activities are included in the scope of certification; when only a part or parts of a company's activities are certified, only the TÜV UK Limited Registration Logo (Paragraph 3) may be used.
- b) May not be displayed on any vehicles owned or supplied by the company.
- c) May not be displayed on flags or buildings (except internal walls and doors and exhibition stands)
- d) Shall be displayed as shown above in either black and white or single colour, provided that this is the only or principal colour of your stationery.
- e) UKAS logos shall normally have a minimum height (excluding accreditation number) of 20 mm and must be legible with no infillings; electronic versions should avoid degradation and/or distortion.
