Benefits of certification

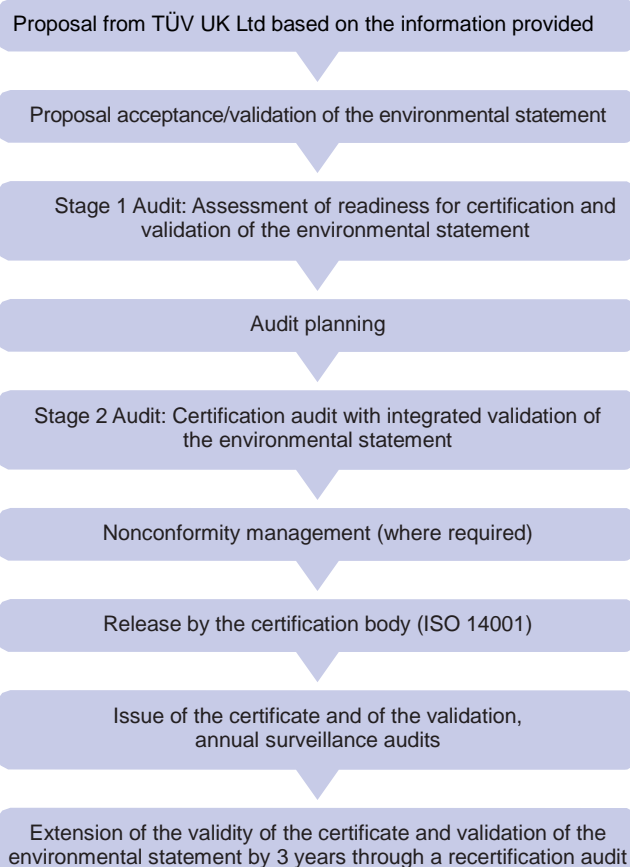
