

Questionnaire to calculate FSC® administration fee

Please complete this form and sign it, and return it to us together with the contract, of which it forms an integral part,

Each FSC-certified organization must pay an **annual administration fee (AAF)** to FSC International, This fee must be collected by the relevant certification body and is transferred 100% to FSC International. The fee is included in the invoice for the FSC-CoC audit. The currency exchange rate on the date of the invoice applies.

The amount of the fee depends on the annual turnover in wood or wood fibre products of the certified company (independently of the FSC certification) and on the type of certification (individual, multisite or group certification or exceptional single site certification of trading enterprises or multi-site certification of trading enterprises). The most current fee list as published by FSC applies.

We would therefore like to ask you to state the annual turnover of wood and wood fibre products for all sites of the organisation for which FSC certification is applied in the table below. In the case of multisite or group certification (Table 3), the sum of the turnovers of the individual locations results in a classification of the entire organisation, with the corresponding licence fee. Always the fee table according to the most recent revision of the FSC-POL-20-005 is valid.

Only organisations that do not conduct any changes to the traded products (either directly or through outsourcing) are eligible for the trader categories.
