Recommended prior knowledge

The students are expected to know the concept of environmental sustainable development and to have an understanding of an initial review as the basis for establishing an environmental management system. Furthermore, awareness of environmental aspects with due consideration to emissions into air and water, consumption of energy, release onto land, use of raw materials and natural resources is also required. Participants should have experience in the evaluation of activities, products and services in order to identify normal and abnormal conditions. A successful participation is supported by expertise in environmental law. It is recommended that participants attend an EMS Foundation Course in advance.
