The GDPMD certification ensures that organizations involved in the supply chain of medical devices—including importers, distributors, and authorized representatives—comply with the regulatory requirements for the safe distribution and handling of medical devices.

GDPMD certification is mandatory under the Medical Device Act 2012 (Act 737) for companies involved in the importation, storage, distribution, and management of medical devices in Malaysia.
