## Prerequisite/Prior knowledge:

- ♣ All the participants must be certified lead auditors of BS OHSAS 18001 : 2007; cleared earlier IRCA certificated course having the evidence as Lead Auditor's certificate
- ♣ All the delegates / participants are expected to have basic knowledge of the PDCA-cycle, the core elements of management systems, concepts of hazard identification, risk assessment and control, prevention of work-related injury, relevant national and local OH&S legislation and basic requirements of the ISO 45001
- ♣ All the delegates/participants must arrange their own hard copy / soft copy of ISO 45001:2018 standard which is required throughout the online program. **This is essential requirement**
- ♣ Also, availability of a hard / soft copy of ISO 19011:2018 standard with participants would be advisable but not essential
- ♣ All delegates/participants must have a laptop / desktop with front camera/ web camera, with uninterrupted internet connectivity with at least 1Mbps speed. **This is also an essential requirement.** The online program conduct will be in video (with audio) mode with all participants and trainer to ensure two way communication.
- ♣ **Knowledge of English is essential**

## Issue of Certificate:

Certificate of successful completion shall be issued to all the delegates/participants who attend entire duration of the course, in all the sessions and qualify in written examination.

Please note, that the written examination cannot be conducted remotely. Written examination must be taken up within 180 days after completion of the course, at any of the nearest TÜV Nord Offices, with a prior confirmation of at least two weeks in advance. The delegates / participants would be informed in detail about this in the training course.
