### **Manufacturing & Shop Inspections:**

During the manufacturing and assembly process, inspections are conducted to improve the safety, quality and reliability of critical parts, where needed materials are tested for safe operation. The inspection consists of raw material verification, stage inspection and final dispatch inspection.

### **Initial Inspection and Acceptance Tests:**

Acceptance tests generally start during the installation of the ride enabling to trace deviations at an early stage and to correct them during installation. Once the installation is completed the initial inspection are performed by experts and safe operation of the ride is tested by multiple measurements like Electrical Test, Acceleration Test Load and Functional Test, Safety Interlock Test. In addition, the ride environment (queue lines, operator area, decoration) is also assessed.

#### **Periodic Inspection:**

Periodic Inspection are performed annually by our experts to check the changes in the design and performance of a ride including review breakdown and maintenance history. During the inspection, the
