TERMS / CONDITIONS The use of TÜV NORD CERT's Logo

1. TÜV NORD's logo *can be used* as labels, metal plates, banners, billboards at offices, factories or vehicles of the certified company.

2. TÜV NORD's logo *can be put* on any kind of stationeries; for instances, letter heads, invoices, purchase orders and brochures etc.

3. TÜV NORD's logo *can be used* in 5 colors, i.e. Blue (Pantone 294 or HKS 42), Black, White, Grey and Silver.

4. Client may send one copy of your printed materials / documents to TÜV NORD (Thailand) Ltd. (Singapore Branch) for verification the use of TÜV NORD's Logo.

5. If there are any changes in the use of TÜV NORD CERT's Logo, TÜV NORD (Thailand) Ltd (Singapore Branch) will notify the certified companies. The certified companies <u>are obliged</u> to follow the conditions which will be verified by auditors during each audit.

6. The display of such logo must be true and must not be mistaken for an endorsement of a product

7. The TUV NORD CERT's logo are not allowed to be used on test reports, calibration results, or inspection report or test certificate relating product

8. <u>DakkS, IATF, TUV NORD CERT's</u> logo are not permitted on the product or its container or package. All types of products, including bulk packaging and product information such as instruction manual, etc.

9. Do not allow customers to use the logo. Accreditation Body (DakkS, IATF) all cases because it is a mark for Certification Body only

10. The certification mark/logo can be used for work systems that have been certified only. Example in detail in page 2.

The use of TÜV NORD CERT's Logo on Product Packaging

Restrictions are as following details:

1. Customers can specify a message to represent the management system certification on the container or package used to contain the product, including bulky packaging and product information such as an instruction manual. The message must contain the following detail:

- The information of the certified company such as company's name, brand's name and so on

- The details of management system according to specific standard

- Name of certification body (TÜV NORD (Thailand) Ltd. (Singapore Branch))

Example:

Product made by company name has been produced with ISO 9001 (Quality Management System) certified by TUV NORD (Thailand) Ltd. (Singapore Branch) Product made by company name has been produced with ISO 14001 (Environmental Management System) certified by TUV NORD (Thailand) Ltd. (Singapore Branch)

Product made by company name has been produced with HACCP (Hazard Analysis Critical Control Point) certified by TUV NORD (Thailand) Ltd. (Singapore Branch) Product made by company name has been produced with ISO 22000 (Food safety management) certified by TUV NORD (Thailand) Ltd. (Singapore Branch)

2. In the case of reducing the scope of certification it is forbidden to bring the TUV NORD logo to advertising on the product. With reduced scope or has not been certified and must revise public relations documents referring to the mentioned scope

3. In case of certification revocation stop using and publicize or refer to the endorsement.

4. In the event that the agency is certified in the manner Group Certification if any agency stops business, notify TUV NORD, the customer must cease the use and publicize or refer to the certification. Only for that particular agency.

But in the event that the certification is revoked, terminate the use and publicity or refer to the certification entirely

Remarks:

- * TÜV NORD's Logo *must be* used only for the standard that has been certified.
- ** TÜV NORD's Logo *can be used* only the certified company; cannot transfer to other clients.

Example of Logo:
