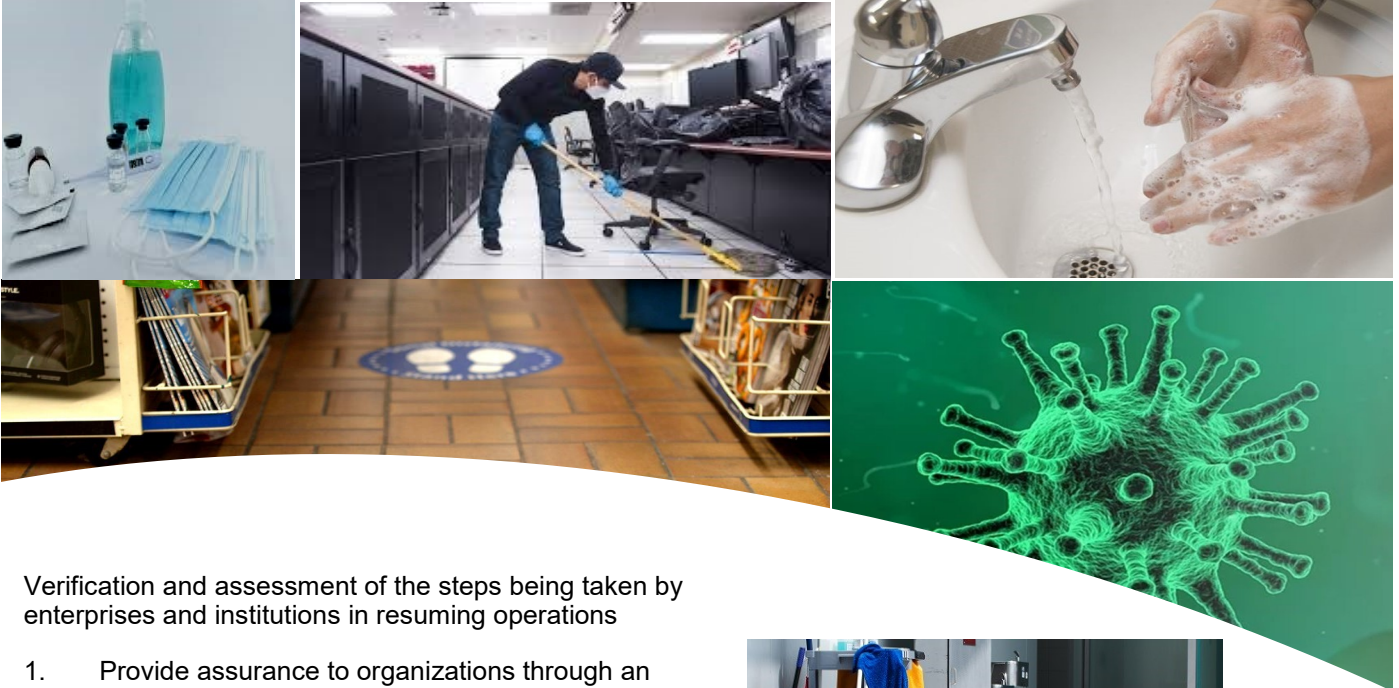


WORKPLACE ASSESSMENT FOR SAFETY AND HYGIENE (WASH)

2. Assessment of compliance towards the latest prevailing mandatory guidelines issued by Ministry of Home Affairs, Govt. of India, current prevailing orders and guidelines from relevant local or state authorities, industry specific guidelines from authorized or expert bodies, TUV India recommended industry specific best practices and any new guidelines as may be issued or revised by authorities as on the date of the audit
